- 6. Ensure that the facilities remain fit for purpose for the future years and that the Club maintains and seeks funding in support of these larger capital expenditures. This is captured in the "Long Term Improvement & Development Plan" (LTIDP) plans brought together by the VHSC.

Membership Secretary Report (David Robson)

Despite the pandemic, it has been an excellent year for membership, building on the success of the last few years. Membership at the end of the financial year (31 March 2021) stood at 167 members and, since the club has re-opened, membership has increased to **214**; this includes **47 new members/past members** who have decided to come back to play again.

The family base continues to be our strength with 25 family groups as members. This is often built on significant junior membership: Wednesday night junior sessions are extremely popular and are driving more families to join.

Total membership is:

- 122 adult playing members
- 15 young adult playing members (18-25 y.o.)
- 61 juniors
- 16 social members

Because the club was closed for six months in the membership year 2020/21, existing members will get six months "free" i.e. membership fees for 2021-22 season will be reduced by 50%; payment will be requested in September / early October.

Director of Squash Report (Tom Swain)

Since the easing of restrictions, the club has seen a steady increase in court usage (see attached spreadsheet) coinciding with the increase in membership.

The club supports a number of sessions across a weekly basis and this feeds in to the healthy situation the club is currently in. The table below has a breakdown of these sessions

NB: Just under 50% of all those that take part in weekly sessions are women/girls – this is considerably higher than the number of individual bookings made by the same group across a week – averaging less than 20%

The club now has 4 qualified coaches – Chris Gorman (soon to be level 3), Tom Swain (level 2), Lorna Lancashire as a Level 1 squash coach now offering 1:1 for beginner players as well as running group sessions with juniors and ladies. Charlie Stow also qualified as Level 1 and introducing new players to the club.

Wednesday Night Internal Team Squash (August/September 2021)

The internal team squash night has been a huge success – 30 players involved, lots of social and some excellent squash across all rankings. We will be looking to recreate this in future months as well as friendly matches with a similar format with other clubs.

The resumption of team squash in the Kent Leagues will take place on Wednesday evenings when it resumes – the club will be looking to enter 2 teams with the possibility of a 3rd team in a development league for less experienced players.

Box Leagues

Currently 40 players across the club leagues with completion of matches consistently being 70%+ since the resumption.

Club Tournaments

The conclusion of the 2020 handicap final is tonight (24th Sept), the plan will then be returning to our calendar of events with the Ladies, Juniors and Vets handicaps to take place before Christmas, Closed competitions in early spring – there is no plan to try and run the missed tournaments due to the lockdowns.

Other Planned Events

- World Squash Day 9th October an event to be planned for the afternoon possibly Family team day
- Pro day Tesni Evans looking to come down at some point for a day/weekend

As director of squash, I would like to thank all those that attend the sessions, sign up for events and play in the leagues as well as those that offer their time to play new and potential members. The club is awesome and goes from strength to strength and that is due to the countless hours and efforts of everybody.

Treasurers Report (Elliot Lancashire)

Accounts to 31st March 2021

Despite a tough year with COVID limiting income from memberships, light deposits and the bar Biddenden Squash Club remains in good financial health due to the receipt of grant income. Gross profit from regular trading sources amounted to £6,741 whilst income from grants amounted to

£29,298. This left the club with a net profit of £6,763 for the year despite an operating loss of £22,536.

Significant expenses included repairs and maintenance of £15,616, clubhouse rent of £4,183 and payroll of £3,967. Further, due to the lack of access to the club, £3,000 of membership income has been deferred. A key deposit accrual was also included at £2,000 to cover all keys on loan to members.

Lastly, the club now uses accounting software to the maintain the financial statements but comparative figures from previous years were not available (as they will be going forwards). However, we can say that total capital and reserves have increased from £4,962 to £11,725 which is excellent news during the pandemic.

I hereby present these accounts to be complete and accurate to the best of my knowledge for consideration by the Club for approval.

The year to 31st March 2022

The overall financial health of the club remains strong with some follow up grants in the early part of the year. This will enable a reduction in returning member fees for 2021/22 (a further note should be issued by David Robson in due course). Alongside this the focus over the coming months will be on continuing to improve the flow, control and timeliness of paying costs (expenses) and receiving membership fees (income) for the club.

Bar Report (Caroline Swain)

The bar usage has increased steadily since reopening at the end of May. We have worked with flexible opening days and hours depending on court usage in an attempt to make the bar as financially sustainable as possible.

Tuesdays still remains our most consistent night, however the Wednesday tournament has had a massive impact. Thank you to Tom for organising this.

Fridays fluctuate with the traditional 'club night' being inconsistent and occasional bookers from newer members. This is an area that could be revitalised so that we are not 'losing' courts and bookings.

We have a few events scheduled between now and Christmas which hopefully will bring back the pre-covid socials that are so greatly missed.
